 NOTICE OF NONCOMPLIANCE; DESIGNATION OF MINOR VIOLATION OF RULES  
 SECTION 120.695, FLORIDA STATUTES

Pursuant to section 120.695, Florida Statutes, the Department of Financial Services (Department) designates the following rules as rules for which a violation would be a minor violation. The Department's referenced divisions will issue a notice of noncompliance as the first enforcement action taken against a person or business subject to the below mentioned regulation. This designation is made based on the Department's determination that a violation of any of the listed rules will not result in economic or physical harm to a person or adversely affect the public health, safety, or welfare or create a significant threat of such harm.
