**RECEIVER'S MOTION FOR ORDER APPROVING TERMINATION OF THE
REHABILITATION OF NEW AMERICA INSURANCE COMPANY, DISCHARGE
ACCOUNTING, ABANDONED PROPERTY REPORT, DESTRUCTION OF
OBSOLETE RECORDS AND FINAL DISCHARGE OF RECEIVER**

THE FLORIDA DEPARTMENT OF FINANCIAL SERVICES as Receiver of New America Insurance Company (hereinafter "New America"), files herewith the Receiver's *Motion for Order Approving Termination of Rehabilitation of New America Insurance Company, Discharge Accounting, Abandoned Property Report, Destruction of Obsolete Records and Final Discharge of Receiver* and in support of its motion states:

1. This Court entered a Consent Order Appointing the Florida Department of Insurance as Receiver of New America for the purposes of Rehabilitation and Notice of Automatic Stay on July 1, 2004.
2. This Court has jurisdiction over the New America receivership and is authorized to enter all necessary and/or proper orders to carry out the purpose of the Florida Insurers Rehabilitation and Liquidation Act, Section 631.021(1), Florida Statutes.
3. Section 631.101(3), Florida Statutes, provides that the Receiver may apply to the Court for an Order terminating the rehabilitation proceedings and permitting the insurer to resume possession of its property and the conduct of its business. While this statute appears to

contemplate the resumption of the business of the insurer, it is also a mechanism for ending a rehabilitation receivership. After six (6) years of receivership, the Receiver is of the opinion that the purposes of the rehabilitation proceeding have been accomplished and therefore the Receiver believes that the receivership should be terminated.

4. New America's insurance policies were cancelled, effective July 31, 2004, pursuant to the Consent Order for Rehabilitation. Many pending claims in litigation were stayed pursuant to the Court Order. The Receiver has resolved all pending litigated claims over the course of the receivership and additionally settled other claims that arose during that time. At the time of this pleading, there are no pending claims in the New America estate. Given the July 31, 2004 policy cancellation date, the general statute of limitations applicable to these policies ran on July 31, 2009.

5. Due to New America's impairment and placement into receivership, New America was required to pay its entire Florida Hurricane Catastrophe Fund ("FHCF") premium for the 2004 contract year pursuant to Rule 19-8.030(6)(d), Florida Administrative Code. The Receiver did not dispute the amount owed to the FHCF and paid the full amount of \$767,738.00.

6. At the time New America was placed into receivership, the Florida Department of Revenue ("FDOR") had an existing dispute regarding certain unpaid premium taxes of New America. New America had claimed an exemption that FDOR established was not available to the company. The Receiver was able to negotiate a waiver of interest, penalties and costs with the FDOR and paid the premium taxes owed in the amount of \$879,945.00.

7. New America had reinsurance agreements with Transatlantic Reinsurance Company (“Transatlantic”). The Receiver commuted the agreements with Transatlantic for \$739,602.00. There are no outstanding reinsurance issues in the New America estate.

8. New America is owned by Newark Insurance Company (“Newark”), a New Jersey domestic stock insurer, as a preferred stockholder, which is a wholly owned subsidiary of Eagle Insurance Company (“Eagle”), also a New Jersey based insurer. Eagle was placed into insurance receivership in New Jersey and pursuant to that receivership Order, Newark was also placed into that receivership as a subsidiary/affiliate.

9. While New America is owned by Newark as the sole preferred stockholder, at the time of receivership New America also had common stockholders. Many of these stockholders are principals in both Newark and Eagle. As a general rule, at the dissolution of a company, the preferred stockholders are paid the remaining assets of the company. As New America cannot return to the business of insurance and the receivership has come to an end, New America should be dissolved, with any remaining assets sent to the New Jersey liquidator of Newark who is the sole preferred stockholder of New America.

10. The Receiver’s Discharge Accounting Statement – Projected as of December 31, 2010 (the “Discharge Accounting”) is attached hereto and made a part hereof as **EXHIBIT A**.

11. As shown in the Discharge Accounting, the estimated value of all assets of New America is projected to be \$625,152.87 as of December 31, 2010.

12. The Receiver receives an annual budget from the State of Florida's Insurance Regulatory Trust Fund ("Regulatory Trust Fund"), which funds a portion of the Receiver's costs and expenses of administration. The Receiver funds the majority and remainder of its budget from the open receiverships it supervises. The portion funded by the Regulatory Trust Fund supports several state funded positions within the Receiver and includes their direct labor and a portion of the Receiver's overhead. Each receivership is charged a portion of these state funded costs and expenses based on certain allocation formulas. It is the Receiver's policy to record these state funded expenditures as "Contributed Equity" on each receivership financial statement. If the Receiver determines that there are sufficient assets available at the end of the receivership, it is the policy of the Receiver to reimburse the Regulatory Trust Fund for Contributed Equity. The Contributed Equity for New America as of September 30, 2010 was calculated at \$29,685.81 and was estimated at \$32,000.00 in the Discharge Accounting (See EXHIBIT A, Page 1, LIABILITIES). The Receiver believes there are adequate assets to reimburse the Regulatory Trust Fund.

13. During the course of the New America receivership, certain property has gone unclaimed. This unclaimed property consists primarily of un-cashed/outstanding return premium drafts, vendor and claim checks at the time New America was placed into receivership. The Receiver has compiled an abandoned property report that lists those entities (942) and the amount each entity is owed. The amount in the abandoned property report is \$193,406.95 and is attached as **EXHIBIT B**. The abandoned property amount should be transferred to the Department of Financial Services Bureau of Abandoned Property at the conclusion of this estate.

14. The Receiver requests authority to retain \$5,000.00 as a reserve for “wind up” expenses of the Receivership. (See EXHIBIT A, Discharge Accounting). The Receiver requests an order authorizing the Division of Rehabilitation and Liquidation to transfer any surplus expense funds remaining after discharge and the balance of the estate’s assets to the New Jersey liquidator of Newark.

15. Upon approval of the Receiver’s request for final discharge, the records of the New America estate will no longer be needed, and it will be necessary to dispose of the obsolete company records. Prior to the actual destruction of these records, the Division of Rehabilitation and Liquidation will obtain a “Disposal Authorization Certificate” from the Division of Archives, History and Records Management of the Florida Department of State.

16. The Receiver requests an Order authorizing the Receiver to remit to the New Jersey liquidator of Newark any assets which may be recovered following the discharge of this receivership if, in the Receiver’s sole discretion, the value of the recovered assets does not justify the reopening of this receivership estate.

17. All mortgages, notes, or other liens in favor of New America recorded with the Clerks of the Circuit Courts in the State of Florida, upon property located in the State of Florida, not sold, transferred, or assigned, by the Receiver are hereby assigned to the New Jersey liquidator of Newark.

18. In addition to this motion for the termination of the New America receivership, the Receiver has surrendered New America’s certificate of authority for transacting an insurance business to the Florida Office of Insurance Regulation (see EXHIBIT C) and will dissolve or let expire the corporation of New America.

19. The Receiver requests an Order that it shall be fully and finally discharged of its responsibilities in the New America receivership.

WHEREFORE, the Receiver respectfully requests this Court enter an Order:

A. Approving the termination of the New America Insurance Company Receivership, as the purposes of the rehabilitation have been fully accomplished, and discharging the Receiver, its deputies and all other employees from any further rehabilitation duties effective at 11:59 p.m. on December 31, 2010;

B. Approving that the Receiver shall transfer any excess funds in the New America estate to the New Jersey liquidator of Newark Insurance Company, the preferred stockholder of New America;

C. Approving and adopting the Receiver's Discharge Accounting;

D. Authorizing and directing the Receiver to reimburse the Regulatory Trust Fund the amount of Contributed Equity calculated as of December 31, 2010;

D. Approving the Receiver's Abandoned Property Report and authorizing the Receiver to transfer \$193,406.95 to the Department of Financial Services Bureau of Abandoned Property as abandoned property;

E. Authorizing and directing the Receiver to retain \$5,000.00 as a reserve for "wind up" expenses. Any residual wind up expenses not utilized by the Receiver shall be paid to the New Jersey liquidator of Newark Insurance Company;

F. Authorizing the Receiver, after final discharge, to destroy any obsolete records in the Receiver's possession;

G. Authorizing the Receiver to remit to the New Jersey liquidator of Newark Insurance Company any assets which may be recovered following the discharge of the New America receivership if, in the Receiver's sole discretion, the value of the recovered asset does not justify the reopening of this receivership;

H. Assigning all mortgages, notes, or other liens, on property located in Florida, in favor of New America Insurance Company to the New Jersey liquidator of Newark Insurance Company.
