The implementation of use of NFPA 1225 as the Standard for Emergency Systems Communications will aid in a better understanding and use of the providing Emergency Services Communications. The Standard, in the development of stage, went through a robust collaborative effort for the improvement of the Emergency Communication Centers encapsulated in the former NFPA 1063 Standard and better use of how, when, and identifying the key stakeholders in providing ERCES as needed. The key definition inclusion of the frequency license holder and other definitions coinciding with and improved language on how and when ERCES systems are deployed, will aid in an improved macro network, and the in building systems installations connected to them. The enforcement aspect of 1225 as opposed to the 1221, will help ensure operability of these systems. After 1221, 2019 Ed, this Standard will no longer be modified, 1225 shall be the applicable standard for the ERCES.
