SUBJECT: NON-ESCHEAT FUNDING SOURCES VERIFICATION

The Department of Financial Services (DFS), Bureau of Vendor Relations, is responsible for maintaining the Federal Funds Table. The Federal Funds Table contains Agency accounts from funding sources exempt from escheatment to the Division of Unclaimed Property when a warrant becomes stale dated.

The Agency Director of Administration (or designee) must submit to DFS annually a list of all accounts from funding sources exempt from escheatment for the current fiscal year for their agency. This list must be provided to the Bureau of Vendor Relations by July 31st. The Bureau of Vendor Relations will update the Federal Funds Table based on the information provided by the Agency.
