## Release 3: Procurement Cloud Transformation

### Next Gen MFMP Reporting

- Key Changes
  - Majority of reports are now self-service in Next Gen MFMP.
  - Data in Next Gen MFMP reports automatically filter to data within your assigned Entity.
  - Next Gen MFMP reports are editable and savable within your own personal workspace.
  - Select reports will be built as dashboards in Tableau and will only be accessible via the Tableau portal.

## Release 3: Procurement Cloud Transformation

### Next Gen MFMP Reporting

#### MFMP Standard Reports

- Anyone with access to MFMP.
- In-application system search functionality for Buying, Invoicing, Sourcing, and Contracts.
- Public reports include transaction-based reports such as All Open Orders, All Open Order with Delay Purchase Until, PRs in Submitted Status, Invoice to Payment Cycle Time, and more.

#### Tableau

- Agency customers are assigned a Tableau license.
- A new MFMP module that allows key agency personnel to perform extensive data analytics of spend and trends.
- Reports include non-transaction-based reports such as User and Groups, User Report, Ship-To, and Bill-To.

#### Secure Reports Site

- Credentials are shared within each agency by the MFMP System Administrator.
- Access an **archive** of operational reports and **historical transaction attachments for requisitions, purchase orders, contract terms, and invoices.**

## Release 3: Procurement Cloud Transformation

**Sourcing and Contracts** will be rolled out to the following pilot agencies on July 5, 2022.

- DMS (State Purchasing and Departmental), HSMV, DCF, FWC

### Sourcing and Contracts Agency Sprint Schedule and Timeline

- **Every 12 weeks after pilot go-live** there will be four sprint releases to roll-out Sourcing and Contracts to remaining agencies.

## Release 3: Procurement Cloud Transformation

- The MFMP team will use various criteria to determine what will be **migrated** to Next Gen Ariba On Demand (AOD):
  - **User Accounts** that have a Last Login Date on or after July 1, 2019.
  - **Contracts** with an effective date of March 2022. Also, active contracts as of July 1, 2022, with PO/Payment activity.
  - **Catalogs** in MFMP as of May 30, 2022.
    - Punchout catalog order must be placed by COB, Friday, June 24, 2022.
  - **Delay Purchase Until (DPU) purchase requisitions** fully approved and awaiting FLAIR Integration approval by close of business on June 17, 2022.

## Release 3: Procurement Cloud Transformation

### Fiscal Year-End and Migration Processes

- **MFMP Buyer is expected to be down for year-end processing from June 30 at 8:00 p.m. to July 5 at 11:59 p.m. ET.**
  - MFMP will send an email to agency customers once MFMP is available after year-end processing and successful migration activities are complete.
  - The MFMP team will begin vendor outreach in June to confirm PO contact and delivery information.
- **Agencies must submit MFMP invoices to DFS, Bureau of Auditing, by 2:00 p.m. ET on Monday, June 13, 2022.**
  - For payments made directly in FLAIR after the cutoff date, agencies should enter the payment information into MFMP via the Payment Update eForm.

## Release 3: Procurement Cloud Transformation

### Dual Processing Period

There will be a dual processing period after Next Gen MFMP goes live on July 5, 2022, until the current MFMP Buyer application is retired in November 2022.

- Current MFMP Buyer application
  - FY 2021-22 purchase orders, certified forwards, change orders, receipts, invoicing, and release encumbrances, only.
    - No new purchase orders
- Next Gen Ariba On Demand (AOD)
  - FY 2022-23 purchase orders, change orders, receipts, invoicing, and release encumbrances, etc. payments made directly in FLAIR after the cutoff date, agencies should enter the payment information into MFMP via the Payment Update eForm.

#### Password management and dual access.



Users who access both systems may need to use different passwords to log into each system as security standards have increased with Next Gen MFMP.
