Real Estate Development and Management: Program Responsibilities



Florida Facilities Pool

- Bonded building pool established in 1985-86.
- 112 facilities, largely multi-tenant office space, including laboratories, and other specialty space.
- Total Division Staff: 284.50 FTEs
 - Regional Facilities FTEs: 59
 - Tallahassee FTEs: 225.50



Lease Administration: 1,500 leases

- \$244 million in commercial leases.
- 6.1 million sq. ft. of Pool leased space.
- 6.1 million sq. ft. of private leased space.
- 1.1 million sq. ft. of other governmental leased space.
- 25,000 parking contracts.



Operations and Maintenance

- Maintain 12.6 million sq. ft. of day-to-day operations
- HVAC controls
- Lawn Care Services for approximately 75 acres



Building Construction

- Design, construction management, and budget oversight on state facilities.
- \$850 million in construction projects.
- New construction and like kind replacements.



Building Systems

- · Building automation.
- Transition to Smart Building Internet of Things.
- Fire and Life Safety.




Business Support Services

- Budget, procurement, contract management, administrative duties, special projects.
- Vendor Contracts: \$13.5 million
- Operating Budget: \$368.1 million




Real Estate Development and Management: DMS Maintained Facility Locations

Assessment Goals


- Reduce Operating Costs

- Provide building-specific strategic recommendations.
- Each building and structure considered for disposition, demolition or redevelopment.
- Relocation of state FTEs to the Capital Circle Office Center (CCOC)


Phases

- Phase one (short term) one-to-five-years
- Future phases (long term) six-to-ten-years

Goals

- Utilize Pool Buildings More Efficiently by Understanding Occupancy and Utilization
- Reduce Number and Size of Private and Other Governmental Leases where Practicable
- Reduce State's Lease Expenditures

Information Gathering

- Published Request for Information Regarding
 Occupancy Sensors and Received Four Responses
- Partnering with the State's Tenant Broker to Gather Data and Assess Possibilities

Pilot

- Piloting Occupancy Sensors in Building 4050
 Summer of 2023
- Provide Data to Leadership and Divisions to Reorganize Leases Based on Actual Utilization

Future

- Potentially Seek LBR to Fund Statewide Program
- Discuss Strategic Goals with Executive Leadership, Agencies, and Florida Legislature
