

Year End Marking of Subsidiaries



The new option *Year End Marking of Subsidiaries and Creation of FCO File* has been added to the 1SX-Request for Certifications Mini Menu, to allow agencies to either exempt, or to allow their

Encumbrances and Payables to be marked for certification and/or to create a FCO file for certifications. Since this option is new to FLAIR, we encourage all agencies to verify their records are correct.

If no changes are made, the Current Year request will be the same as last year's request.

To access the Request for Certification Mini Menu, input 'CF' or '1S' in the TYPE field and 'X' in the SEL field and press ENTER.

To update records, input 'X' next to *Year End Marking of Subsidiaries and Creation of FCO File*, input 'U' in the SEL field and input the 'year' in the Fiscal Year End field and press ENTER.
