ORDER APPROVING FINAL ACCOUNTING  
AND FINAL DISCHARGE, AND AUTHORITY TO REIMBURSE  
THE INSURANCE COMMISSIONERS REGULATORY  
TRUST FUND AND TO TRANSFER REMAINING ASSETS AND ASSIGNMENT OF  
UNRECOVERED ASSETS TO THE FLORIDA INSURANCE GUARANTY ASSOCIATION  
AND AUTHORIZING THE DESTRUCTION OF OBSOLETE RECORDS.

THIS CAUSE came on for hearing on the Ancillary Receiver's Motion for Approval of Final Accounting and Final Discharge and, Authority to Reimburse the Insurance Commissioners Regulatory Trust Fund and To Transfer Remaining Assets and Unrecovered Assets to the Florida Insurance Guaranty Association and Authorizing the Destruction of Obsolete Records, and the being otherwise fully advised in the premises, it is

ORDERED and ADJUDGED that:

1. The Ancillary Receiver's Final Accounting is hereby approved and the Ancillary Receiver's administration of this receivership shall be deemed satisfied, approved, and confirmed in all respects, and the Ancillary Receiver, its deputies and all other employees shall be discharged without further order of this Court, from any and all duties, obligations and liabilities in the administration of the ancillary receivership at 12:01 A.M. on the 20th day of September, 1993. The Ancillary Receiver, after offering the company records in its possession to the Domiciliary Receiver, is authorized to destroy the records belonging to the


company. Prior to the actual destruction of any records, a Disposal Authorization Certificate shall be obtained by the Department of Insurance from the Division of Archives, History and Records Management of the Department of State. The provisions of this paragraph shall survive the entry of the Final Discharge.

2. The Ancillary Receiver is authorized and directed to transfer \$21,862.57 to the Insurance Commissioner Regulatory Trust Fund.

3. The Ancillary Receiver is authorized and directed to transfer \$543,758.53, plus accrued interest, to Florida Insurance Guaranty Association.

4. The Ancillary Receiver is authorized and directed to assign unrecovered assets to the Florida Insurance Guaranty Association.


