**ORDER APPROVING THE DEPARTMENT'S MOTION FOR ORDER  
APPROVING FINAL CLAIMS REPORT, CLAIMS DISTRIBUTION REPORT,  
DISTRIBUTION AND DISCHARGE ACCOUNTING STATEMENT,  
DIRECTING FINAL DISCHARGE OF RECEIVER, AUTHORIZING  
DESTRUCTION OF OBSOLETE RECORDS, AND DIRECTING  
DISPOSITION OF REMAINING ASSETS AND CLOSING ESTATE**

THIS MATTER came on upon the Florida Department of Financial Services, as Receiver of Caduceus Self Insurance Fund, Inc.'s (the "Department") *Department's Motion for Order Approving Final Claims Report, Claims Distribution Report, Distribution and Discharge Accounting Statement, Directing Final Discharge of Department, Authorizing Destruction of Obsolete Records, and Directing Disposition of Remaining Assets and Closing Estate.* The Court having reviewed the ~~pleadings of~~ *motion Jc* record and being otherwise fully informed in the premises, finds as follows:

It is **ORDERED** and **ADJUDGED**:

1. The Department's Final Claims Report is approved and adopted;
2. The Department's Discharge Claims Distribution Report is approved and adopted;
3. The Department's Distribution and Discharge Accounting is approved and adopted;
4. The Department is authorized and directed to reimburse the Florida Regulatory Trust Fund in the projected amount of \$278,076.20 for contributed equity in the Caduceus estate;

5. The Department is authorized and directed to retain \$6,000.00 as a reserve for "wind up" expenses of the Department with any surplus remaining from the \$6,000.00 and the balance of the estate's assets shall be paid to Claimants Joel S. Mutnick and Fiske and Company;

6. The Department is authorized, after final discharge, to destroy any obsolete records in the Department's possession;

7. The Department is authorized to remit to Claimants Joel S. Mutnick and Fiske and Company any assets which may be recovered following the discharge of this receivership if, in the Department's sole discretion, the value of the recovered assets does not justify the reopening of this receivership;

8. The Department is directed to assign all mortgages, notes, or other liens, on property located in Florida, in favor of ICF to Claimants Joel S. Mutnick and Fiske and Company; and

9. The Department is discharged, without further Order of this Court, of its responsibilities in this receivership estate as of 12:01 a.m. on December 31, 2016.

*10. The 10-18-16 order remains in effect.*
