The Court having reviewed the motion and otherwise being fully advised in the premises, it is hereby **ORDERED AND ADJUDGED** as follows:

- A. The Motion is Granted in all respects.
- B. Paragraph E of the Discharge Order entered on June 28, 2017, is amended to read: The Department is authorized to (a) remit to the applicable guaranty association any other assets which may be recovered following the discharge of this receivership if, in the Department's sole discretion, the value of the recovered asset does not justify the re-opening of this receivership estate; and (b) execute, on behalf of Homewise Insurance Company, any documents necessary to effectuate the recovery and remittance of such assets.
- C. The terms of the Discharge Order which are not otherwise changed by this Order remain in full force an effect.
