**ORDER APPROVING THE FLORIDA DEPARTMENT OF FINANCIAL SERVICES'  
FIRST INTERIM CLAIMS REPORT AND RECOMMENDATION ON CLAIMS**

THIS CAUSE came before the Court for consideration upon the Department of Financial Services as Receiver for Florida Specialty Insurance Company's (hereinafter "Department") Motion for Order Approving First Interim Claims Report and Recommendation on Claims. The Court having considered the Department's motion and being otherwise fully advised it is:

**ORDERED AND ADJUDGED** as follows:

A. The Department's First Interim Claims Report and Recommendation on Claims is hereby Approved;

B. The Department is Authorized to use the sample Notice of Determination and Directed to provide notice to each claimant of the Department's recommendations regarding its claim, by U.S. mail and/or electronic mail to the last known physical and/or electronic mail address as shown in the Department's files or to any subsequently revised address of such claimant as ascertained by the Department;

C. The Department is Authorized and Directed to update its records to incorporate change of address information for an interested individual/entity (e.g. agent, claimant, creditor, policyholder, subscriber) if the Receiver determines that there has been a change of address for an interested individual/entity and the Receiver is to use the change of address information for future mailings;

D. The Department is Authorized and Directed to establish an objection filing deadline that is not less than forty-five (45) days from the date of this Court's order granting approval of the Report;

E. All persons or entities who have filed claims, or had them deem filed, as reported to the Court, is Directed to file any objection that they may have to be the Department's Report with the Clerk of this Court on or before 11:59 p.m. on the objection filing deadline at:

F. Any person or entity filing an objection is required to clearly state the name and claim identification number of the person or entity filing the objection and is to provide documentation supporting the objection and claim. The Court will not consider any information or documentation submitted after the objection is filed;

G. The Department's procedure for recognizing and accepting assignment of claims is hereby Approved;

H. The Department's procedure for addressing late-filed objections is hereby Approved; and

I. The Department's First Interim Claims Report and Recommendations on Claims for which no objections are filed are hereby Approved.
