NOTICE OF BANK ACCOUNT FREEZE AFFECTING CHECK PAYMENTS

(FedNat Insurance Company, in receivership)

On September 27, 2022, FedNat Insurance Company (“FedNat”) was ordered liquidated by the Second Judicial Circuit Court in Leon County, Florida. The Florida Department of Financial Services (“Department”) is the court appointed receiver. Prior to the liquidation, FedNat and Maison Insurance Company (“Maison”) were merged into one entity. FedNat is the surviving entity after the merger.

FedNat’s financial condition has necessitated the freezing of its bank accounts effective immediately. As a result, this notice is to advise you NOT to deposit any FedNat or Maison check in your possession. Depositing a check after the freezing of the bank accounts may result in you being assessed fines or penalties by your bank which are not reimbursable.
