



AMC001 – Asset and Property

AMC001 converts active asset records, including Attractive Item records, from FLAIR Information Warehouse Property Master (PROPMSTR) and Property Custodian information (PROPCSTO) tables to Florida PALM. The conversion of asset records is required to continue the business process of maintaining asset records over an asset's life cycle including maintenance, depreciation, transfers, dispositions and physical inventory.

Review the Mock Conversion 2 results for AMC001, which includes data as of March 3, 2025. Validate the active assets listed and resolve errors by updating records in FLAIR. The most common errors and the recommended action to resolve errors are provided in the table below. If you do not need the asset converted into Florida PALM, you can simply inactivate the record in FLAIR.

NOTE: In future Mock conversions, if the asset record does not have a valid project, grant or contract, the asset record will still be loaded; however, the respective field will be blank.
