

GMC001 – Grants (for accounting purposes)

GMC001 is needed to convert active grants to Florida PALM.

NOTE: *Grant Life-to-Date balances will not be converted to Florida PALM. Reference the [Know Your Change Impact: Life-to-Date Balances flyer](#) for additional details.*

During Mock Conversion 4, GMC001 was run twice. After the first run in October 2025 (data as of September 27, 2025), the following results were shared with agencies:

- Valid grants were provided to agencies in the <Agency> Grant Lookup worksheet in Smartsheet to support configuration activities.
- Grants that did not successfully convert were provided to agencies to help support data cleansing efforts.

A second run of GMC001 was completed in November. This “delta” file contains grants that met one of the following between September 28 (original run date) and November 8 (second run date):

- New grant records added in FLAIR; or
- Previously errored grants that have been updated (cleansed) in FLAIR to now meet the criteria to successfully load in the conversion.

NOTE: *If you had no grants that met the criteria for the delta run in November, you will only receive conversion files for the first run in October.*

Using the files provided, agencies should complete the following:

- Review the October and November Log Files for a summary of processed and rejected records.
- Review the November Error File for grants that were unable to successfully convert after both runs were performed.

These files should be used to validate the active grants that converted and address errors by updating records in FACTS. The most common errors and the recommended action to address errors are provided in the table below.

NOTE: *If you do not want a grant converted, you must inactivate the grant in FACTS or FLAIR, as applicable.*

NOTE: *FACTS exempt agencies (DACS, DLA, and LEG) must correct errors in FLAIR. All other agencies will correct errors in FACTS.*

Table 1: GMC001 Common Errors and Recommended Action

Common Error Messages in Error File	Recommended Action in FACTS or FLAIR
Required Field Grantor ID is missing	Add a valid Vendor ID (use the Mock Conversion 4 Supplier Crosswalk located in SharePoint for reference).
Invalid Grantor ID for Grant	Agencies should update the Grantor ID within FACTS or FLAIR, as applicable, to a value that will successfully crosswalk to a Florida PALM Supplier. Agencies can use the Florida PALM

Common Error Messages in Error File	Recommended Action in FACTS or FLAIR
	<p>Supplier Crosswalk located in SharePoint to aid in choosing a valid value.</p> <p>Agencies must verify all remaining information on the record. Ensure the ALN and CSFA, if applicable, are valid Florida PALM values, and the Grant Start Date is before the Grant End Date. This will ensure the record does not error out in future conversions for any other reason.</p>
Invalid value ALN provided for field ALN	<p>Determine if the grant needs to be inactivated or if the ALN value should be updated for the grant record.</p> <p>NOTE: <i>If the Grant Record has an invalid ALN, it is likely the grant should be closed in FACTS and inactivated in FACTS/FLAIR.</i></p> <p>NOTE: <i>ALN values that are valid in Florida PALM are available for review in the Knowledge Center. ALNs must have been included in the active value list provided by sam.gov as of 10/04/2025.</i></p>
Invalid value CSFA provided for field CSFA	<p>Determine if the grant needs to be inactivated or if the CSFA value should be updated for the grant record.</p> <p>NOTE: <i>If the Grant Record has an invalid CSFA, it is likely the grant should be closed in FACTS and inactivated in FACTS/FLAIR.</i></p> <p>NOTE: <i>CSFA values that are valid in Florida PALM are available for review in the Knowledge Center. CSFAs must have been certified and included in the catalog for FY23, FY24, and FY25 to be configured in Florida PALM.</i></p>
Grant Amount should be greater than zero	<p>Add a valid grant amount greater than zero or make Grant ID inactive.</p> <p>NOTE: <i>Grant Amount should not equal zero. A Grant Balance can be zero once the Grant Amount minus all expenses is equal to zero; however, the Grant Amount is always the original amount of the grant.</i></p>
Start Date cannot be greater than End Date	<p>Update start date and end date or make Grant ID inactive. (Grant Start Date must be before the Grant End Date.)</p>
Invalid Character in ChartField value	<p>Special characters are not allowed in ChartField values or their descriptions. Agencies should consider inactivating the invalid value and creating a new value without special characters.</p> <p>ChartField values may not contain the following special characters: !, @, #, \$, %, ^, &, *, (,), -, ., <, ?, ', comma, or space.</p>

Common Error Messages in Error File	Recommended Action in FACTS or FLAIR
	Agencies should reference guidance on the Use of Special Characters within Florida PALM document for additional information.

NOTE: If a Grant is marked closed in FACTS the agency should verify the Grant is also marked closed in FLAIR. NOTE: All ALN and CSFA values that errored for Mock Conversion 4 were confirmed inactive prior to 2021.

NOTE: Special characters in ChartField description fields were replaced with an underscore to prevent the conversion from erroring.
