IV&V Update

Project Management

- The IV&V Team is tracking the delayed tasks in the Florida PALM Project Schedule
 - As of mid-October, there were 312 total delayed tasks, with 294 related to the Design Segment II
 - The Schedule Performance Indicator (SPI) continues to stabilize and is showing a consistent 0.88 across the past several weeks, indicating that the Florida PALM Project Team is settling into a steady pace of work completion





IV&V Update

Project Management Cont.

- The IV&V Team reviewed the Implementation Activities slides used in ESC Presentations, utilizing the September ESC Slides for the review
- The IV&V Monthly Assessment Report detailed recommendations for how the slides may include additional information to provide more insight for the ESC members
 - These recommendations do not change the risk level associated with the Project Management Focus Areas, they are suggestions to add clarity and detail to the activities related to Design in keeping the ESC members up to date
 - Suggestions include:
 - Demonstrating future trends based on the current pace
 - Detailing the Actuals versus Planned and further insight into the pie charts
 - Detailing the legend and meanings behind the pie charts and how the ESC can interpret the message being told by those diagrams





IV&V Update Open Findings

- Opened an Issue in the IV&V September Monthly Report: Finding 12 Inconsistency in Requirements Traceability
 - The Florida PALM IV&V Team provided a list of identified inconsistencies associated with D636, which were addressed before the deliverable's acceptance
 - The Florida PALM Project Team incorporated additional cross-checks of requirement traceability between documents before submitting the subsequent Completion of Solution Design deliverables
 - Discussed the option for only updating the RTM or RICEFW and then referencing those documents in the subsequent deliverables to avoid future inconsistencies
 - SSI Vendor preferred to continue embedding requirement traceability in Functional Designs, so developers have all the information in one place
 - The Florida PALM IV&V Team will validate if additional cross-checks are sufficient to avoid inconsistencies between documents

IV&V Update Functional Design

- The IV&V Team attended:
 - Payroll Business Process Model reviews and Technical Town Hall meetings (9/18 -9/19)
 - Segment I Design Workshops (10/3 10/4)
 - All sessions were well attended by Agencies, provided key information, generated questions, and provided clarification on Florida PALM functionality
- Segment II Design Sessions are continuing but are behind schedule
 - If the current trend of functional design approvals continues, then Segment II Design completion could be delayed by 4 weeks
 - Segment II delays are not expected to impact the Ready to Start Build Stage Gate
 - Only 50% (39) of Segment II design specifications need to be approved
 - The criteria have been met as of 10/20/23

IV&V Update Readiness Tasks and Agency Engagement

- The Florida PALM Project Team released Tasks 500 504 in October, which aim to improve agency project management planning for the Florida PALM transition. The Florida PALM IV&V Team views these tasks as providing a positive direction to improve agency readiness.
- The Florida PALM IV&V Team has scheduled discussions with several agencies to discuss their experiences and challenges with funding requests and planning for the transition to Florida PALM
 - The IV&V Team completed some agency discussions. IV&V will be consolidating all responses and analyzing them for common trends.
 - The results of the outreach and any IV&V recommendations will be shared with the Florida PALM Distribution List in a future report





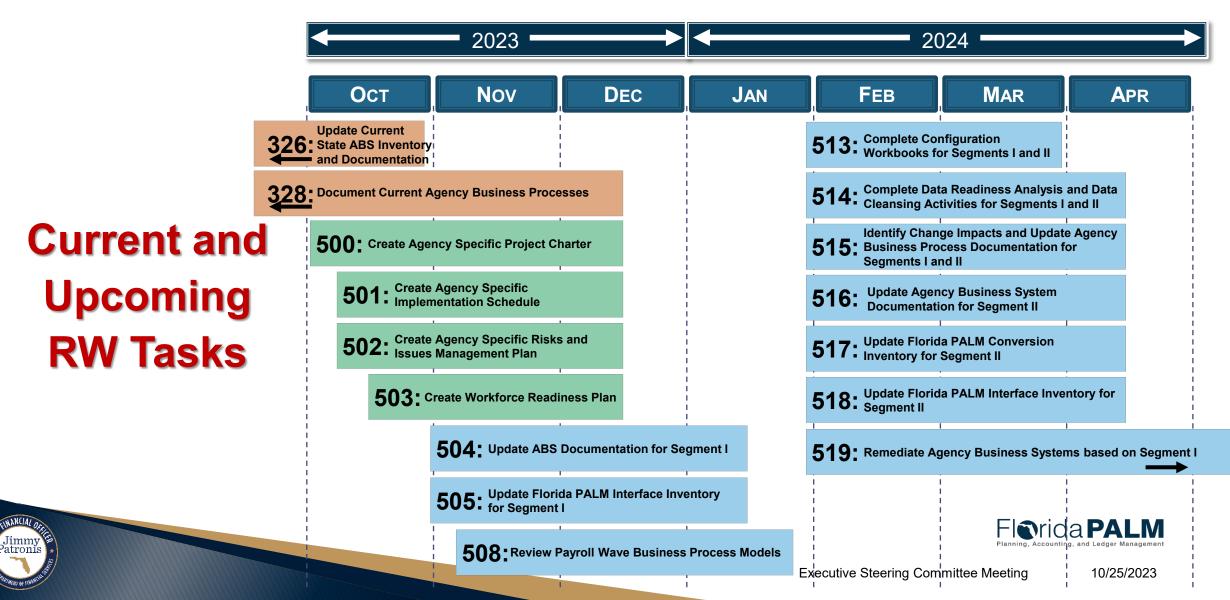

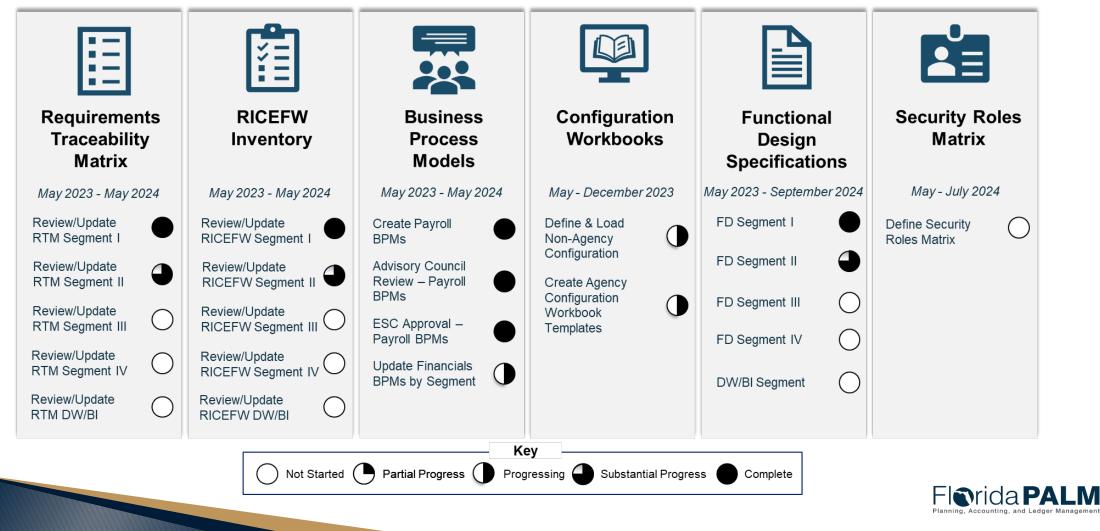

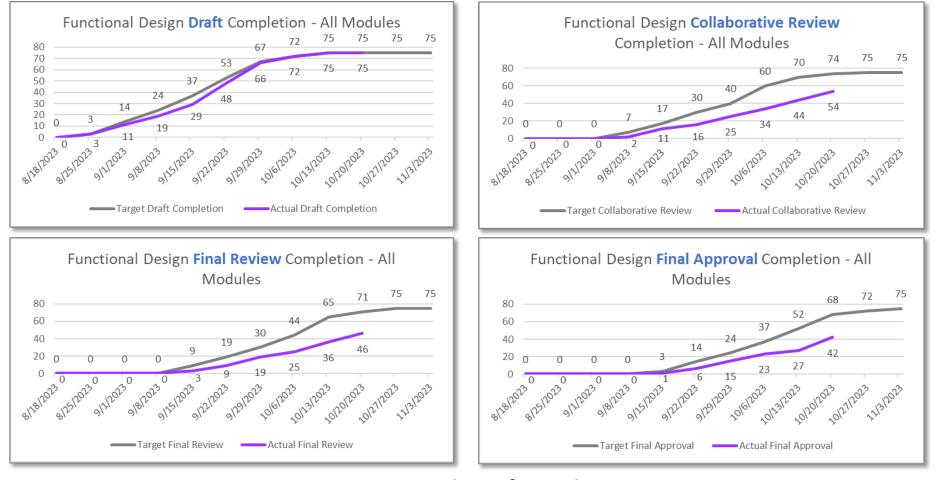

Segment II Functional Design Status



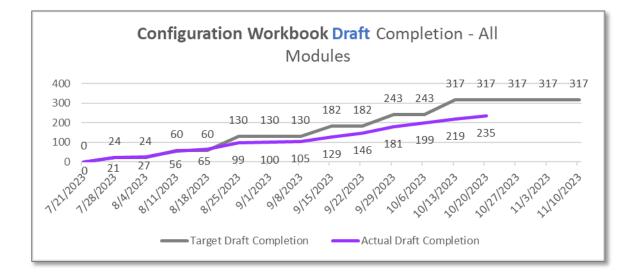


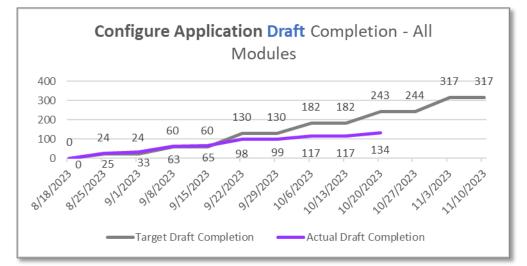

A defined point in the Project at which the Department or the Executive Steering Committee makes a decision whether to proceed with a subsequent Project Stage or activity.

- Stage Gate 1 Ready to Build:
 - Planned Decision (contract) November/December
 - Criteria (contract)
 - Design Segment I is complete (accepted on Aug. 29, 2023)
 - Design Segment II is at least 50% complete (expected to be 100% by November 3, 2023)
 - Anticipated Decision November 9, 2023

Recommended Statutory Changes

SB2502 – GAA Implementing Bill, which creates the Florida PALM ESC, requires that the ESC:

(4)(a) Identify and recommend to the Executive Office of the Governor, the President of the Senate, and the Speaker of the House of Representatives any statutory changes needed to implement the replacement subsystem that will standardize, to the fullest extent possible, the state's financial management business processes.

Recommended Statutory Change

215.422(16) Nothing contained in this section shall be construed to be an appropriation. Any interest which becomes due and owing pursuant to this section shall only should be payable paid from the appropriation charged for such goods or services or from an available and allowable appropriation for such charges.





- Project Change Request 107: Default Amount Only Flag and Requirement Updates
 - Attachment 5.1 Business Requirements
 - Moved to Optional Services: All are related to multi-year encumbrances and recurring vouchers which will not be implemented at the Financials Wave
 - 30.0055 Provide ability to track contract expenditures and encumbrances across multiple fiscal years against contract budgets and ensure expenditures plus encumbrance balances do not exceed contractual amounts.
 - 30.0060 Provide ability to include the charts of accounts code structure for multiple fiscal years.
 - 30.0280 Provide ability to modify amount, accounting classification or payment terms on any recurring payment.
 - 30.0308 Provide ability to automatically establish recurring payments with an end date and established frequency (e.g., monthly, quarterly, annually), extension capability, and the ability to modify chart of accounts coding.
 - 30.0454 Provide ability to record, maintain, and report the following information, including but not limited to: the ability to establish and/or modify encumbrances for current fiscal year and amounts needed for future fiscal year encumbrances, based on chart of accounts code structure, for purchase orders or other procurement contracts and agreements.
 - 30.0480 Provide ability to require that recurring payment transactions obtain approvals via the standard Workflow process
 prior to making payment.
 - 30.0518 Provide ability to route encumbrances with future fiscal years through a budget check and approval flow when the future fiscal year becomes available.

 - 100.0159 Provide ability to suspend or delete user data when a user's employment is terminated. Maintain security parameter settings for the user in an inactive status in case security is re-activated in the future.

Records should be protected and ensure their accuracy and ready retrieval throughout the storage period. Access to audit trail should be limited to authorized and need to know personnel only. System should record the date and time of used entries and actions, modifications and deletion of records in system.

 - 200.1099 (New) Provide ability to only view and select active SpeedKeys on AR transactions.
 - Supports creation of SpeedKeys using as much delivered functionality as possible.
 - 30.1023 (New) Provide ability to systematically designate encumbrances and payables to be vouchered by amount vs. quantity.
 - Supports proposed customization C93 Default Only Flag, which simplifies the on-line encumbrance process

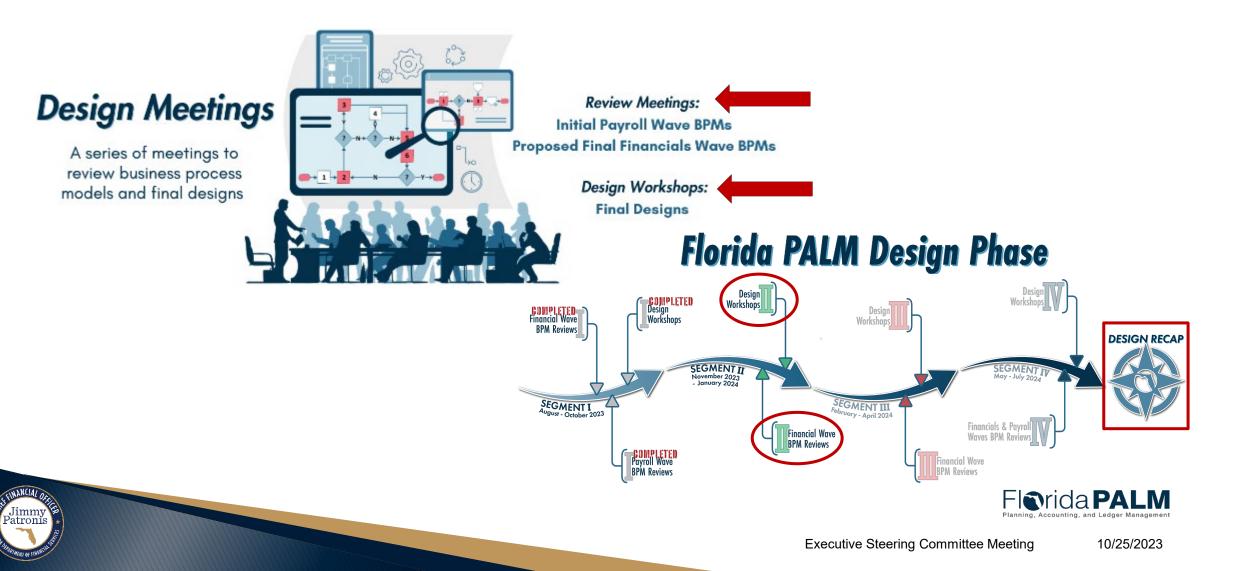
