User Stories

- During IV&V's review of Amendment 8, IV&V noted that there is no plan to implement User Stories for the Financials and Payroll Waves.
- User Stories are an integral part of a development project as they document user processes and can be used to test the system once configured. They also allow users to understand how they will accomplish tasks in Florida PALM by referencing what a user does by role.
- ▶ IEEE 830, PMBOK®, and the BABOK® Guide all recognize User Stories as a critical part of the end user perspective.
- ▶ For best implementation practice, User Stories should be linked to associated requirements from the Requirements Traceability Matrix and business process models.



Florida PALM Project Monthly Agency Status Reports

- The Florida PALM Project Team is required to provide monthly Status Reports with Agencies' ongoing Project efforts required for deployment of PALM functionality (General Appropriation Act FY 22-23, Specific Appropriation 2395).
- IV&V is reviewing the Agency Status Reports, validating that the information conveyed is complete and accurate.
- Additionally, IV&V is reviewing industry best practices in relation to status reporting and engagement, and leveraging our experience to assess what has worked in similar projects conducted in other states.
- Once our review is complete, IV&V will share the results and recommendations with the Florida PALM Project Team.



Readiness Workplan

- The Florida PALM Project Readiness Team uses the Readiness Workplan to assign agencies tasks to engage them in analyzing their current FLAIR processes and prepare for upcoming PALM Financials and Payroll waves.
- The Florida PALM IV&V Team completed a review of the Florida PALM Project Readiness Workplan.
- In this review, IV&V interviewed the Florida PALM Project Team and selected agencies and studied active Readiness Workplan tasks and related materials.
