## Reinsurance Intermediary Brokers and Managers Appointment– Individuals

**Effective July 1, 2023, the Reinsurance Intermediary Brokers and Managers license will no longer be available.** Those individuals wanting to be a Reinsurance Intermediary must get a Reinsurance appointment under a General Lines, Personal Lines, Life, Health or Health, and Life Insurance including Annuities and Variable Contracts license.

### Common Use(s) of License:

Florida Statutes [626.7492](#) defines a "REINSURANCE INTERMEDIARY BROKER" (RIB) as a person other than an officer or employee of the ceding insurer, who solicits, negotiates, or places reinsurance cessions or retro cessions on behalf of a ceding insurer without the authority or power to bind reinsurance on behalf of the ceding insurer.

Florida Statutes [626.7492](#) defines a "REINSURANCE INTERMEDIARY MANAGER" (RIM) as a person who has authority to bind, or who manage all or part of the assumed reinsurance business of a reinsurer, including the management of a separate division, department, or underwriting office, and act as an agent for reinsurer whether known as a reinsurance intermediary manager, manager, or other similar term.

### Steps To Obtain a 0061, 0062, 0063, 0064 Reinsurance Individual Appointment

#### **Step 1 – You must hold a Florida Agent/Producer Insurance License.**

- You must hold a Florida Resident or Nonresident General Lines, Personal Lines, Life, Health, or Health and Life Insurance including Annuities and Variable Contracts license.

#### **Step 2 – Obtain Reinsurance Appointment:**

- Self-appoint with a Reinsurance Appointment.
  - Log into your **Agency [MyProfile](#)** Account and select **Access eAppoint** website to submit a new Reinsurance Appointment.

### THE FOLLOWING PERSON ARE NOT CONSIDERED RIMS:

- Employee of the insurer.

- An underwriting manager who manages assumed facultative risks for a reinsurer, if the facultative reinsurance business managed by the underwriting manager is less than 10 percent of the assumed annual gross written premium of the reinsurer.
- Manager of the U.S. branch of an alien insurer.
- Underwriting manager who manages all the reinsurance operations of the reinsurer, who is under common control with the reinsurer subject to the Holding Company Act and his compensation is not based on premiums written.
- Manager of a group, association, pool, or organization of insurers engaging in joint underwriting or joint reinsurance which is subject to examinations by the insurance regulatory authority of the state in which the manager's principal business is located.
