Cypress Property & Casualty Insurance Company requested an overall statewide **average rate increase of 26.3%** for homeowners insurance policies in its "Florida Evergreen" Homeowners Multi-Peril Program with an **effective date of December 22, 2021**, for both new and renewal policies. The filing was submitted under the Use and File category, which means that the company can implement the rate prior to the Office of Insurance Regulation's approval. If the rate is not approved, the company must issue refunds to policyholders.

The Office of Insurance Regulation (OIR) is hosting a virtual public Rate Hearing on **January 21, 2022**, in order to conduct fact finding and to gather additional information to assist OIR in determining if the rate request is justified.
