



Storm Recovery Grants Available Now in 49 Counties

This year, the U.S. Department of Housing and Urban Development (HUD) has provided funds to support long-term recovery efforts from the storms Floridians experienced in 2023 and 2024. The grant programs below were established with these recovery funds and are open and available now.

Rebuild Florida 2023 and 2024 Storms Program

The **Rebuild Florida 2023 and 2024 Storms Program** offers reconstruction, manufactured housing unit replacement, or rehabilitation for homes damaged by 2023 and 2024 storms. Priority funding will be provided to the most vulnerable populations, including the elderly, those with disabilities, families with children under the age of 18, and families with low household incomes.



Eligible storms and counties include:

- Hurricane Idalia (2023); Hurricanes Debby, Helene, and Milton (2024); and North Florida severe storms, winds and tornadoes (2024).
- 47 Eligible Counties: Alachua, Baker, Bradford, Brevard, Charlotte, Citrus, Clay, Collier, Columbia, DeSoto, Dixie, Duval, Flagler, Franklin, Gadsden, Gilchrist, Glades, Gulf, Hamilton, Hardee, Hendry, Hernando, Highlands, Indian River, Jefferson, Lafayette, Lake, Leon, Levy, Liberty, Madison, Marion, Martin, Nassau, Okeechobee, Osceola, Palm Beach, Polk, Putnam, Seminole, St. Johns, St. Lucie, Sumter, Suwannee, Taylor, Union and Wakulla.

Better Future Individual Housing Program - Pasco County

The **Better Future Individual Housing Program** provides assistance to Pasco County residents to repair, rebuild or replace homes damaged by Hurricanes Idalia, Helene and Milton.



Homeowners and landlords with small rental properties (1–4 units) in Pasco County who had damage from Hurricanes Idalia, Helene or Milton can apply. Priority will be placed on:

- Low-income households
- Seniors (ages 62+) and people with disabilities
- Families with children ages five and under
- Residents displaced or living in unsafe housing

People First Hurricane Recovery Programs - Pinellas County

Funding is available to eligible Pinellas County residents through one of five **People First Hurricane Recovery Programs**:



1. Homeowner Rehabilitation/Reconstruction Program

Funding to repair, rebuild, or replace hurricane-damaged homes

2. Homeowner Reimbursement Program

Reimbursement for repair work you have already completed

3. Local Landlord Program

Support for landlords to repair or rebuild rental properties to rent as affordable housing

4. Disaster Relief Reimbursement Program

Help for income-eligible homebuyers to purchase a safe home outside flood zones

5. Homebuyer Assistance Program

Reimbursement for essential disaster-related expenses such as rent, mortgage, or utilities

Sunrise St. Pete Program

The [Sunrise St. Pete Program](#) offers financial assistance to help with home repair, rebuilding, elevation, and reimbursement for expenses related to Hurricanes Idalia and Helene – helping residents restore their homes, prevent long-term displacement, and maintain safe, resilient housing.

Through the City's No Wrong Door approach, applicants will apply through a single application portal, and based on each household's unique circumstances, are matched with the assistance that best meets their needs:

- **Rehabilitation, Reconstruction, and Elevation Assistance:** Help for homeowners and small landlords (up to 4 units) to repair, rebuild, or elevate eligible storm-damaged homes, with a priority placed on low- and moderate-income owner-occupied homes.
- **Reimbursement for Repair:** Reimbursement for verifiable eligible expenses already incurred to repair, demolish, or reconstruct homes damaged by a qualifying hurricane. Only fully-permitted, code-compliant repairs completed before applying to the program are eligible for reimbursement.
- **Disaster Relief Payments:** Reimbursement for rent, mortgage and utility payments for up to six consecutive months for eligible low-to-moderate income tenants and homeowners with demonstrated hardship caused by a qualifying storm.
