## Monroe County Homeowners Insurance Consumer Survey Report







Consumers' feedback is important to me and will help me develop legislative changes to improve the homeowners insurance market in Monroe County.

The survey was available online and distributed to Monroe County residents with the assistance of local stakeholders. This report illustrates the responses I received from 622 Monroe County residents during a two-week period in November 2023.

#### **Property Type**











## Mortgage Payment Increase Due to Insurance Premium Increase




#### **Homes That Exceed Eligibility Limits for Citizens Citizens Insurance Policy**





#### **Monroe County Residents with Flood Insurance Coverage**




#### **Purchased Flood Insurance Before** the Citizens Requirement



Residents Added Contents Coverage Due to the Citizens Requirement


#### **Amount of Flood Insurance Premium Increase with Contents Coverage**







