The Fire and Emergency Incident Information System Technical Advisory Panel meeting was called to order.

On a motion duly made, the minutes from the Fire and Emergency Incident Information System Technical Advisory Panel held on April 14, 2009 were approved.

REPORT FROM DIVISION: *Given by Director Halas*

The 2008 Florida Fire Report is close to being complete and being sent to the printer.

Deputy CFO Brian London and Director Halas spent several days in Ocala at the Fire College along with 55 other staff members from the Division, all four Bureaus

represented, and took part in a strategic planning summit along with Dr. Scott Helger, facilitator from Florida State University.

The Strategic Plan will be out within the next couple of months as the document is finalized.

There are three areas of accreditation that are being explored. The Bureau of Fire & Arson Investigation is in the accreditation process under FDLE and that should be finalized this spring. Also, the Forensic Lab is seeking accreditation through a different institution and they are under a similar timetable. The Bureau of Fire Standards & Training are also re-visiting the accreditation process and reviewing some of the programs that were accredited over a decade ago and also bring some of our new programs to the table.

REPORT FROM FFIRS: *Given by Keith McCarthy*

The 2008 Annual Report “Florida Fires” has been submitted to Pride Enterprises for production. The schedule completion date is August 15, 2009.

Letters as well as certificates of appreciation for participation are currently being prepared.

A list of non-reporting fire departments was provided to the Panel. Along with a copy of the 2008 Annual Report, these departments will be receiving a letter requesting their participation in the FFIRS program.

June 30, 2009 was the deadline for departments to submit 2008 data. (USFA guidelines)

Currently 63% of fire departments that reported for 2008 (90%) are reporting for 2009.

194 departments have not reported for 2009 as of 7/17/09.

Early reporting is strongly encouraged. It seems as though the larger departments are waiting until the end of the year to report.

The currently used federal software is available free of charge for any department that needs it.

Current problems are the issue of multiple units responding to an incident. It is important for an “Action Taken” (cancelled in route) be reported by one of the units so the report does not get canceled out.

The crosswalk with EMS is still being looked at. No new developments. Hopeful for grant funding.

Chief Angle stated that the Panel needs to move on from reporting issues which appear to have been solved. The Panel needs to concentrate on combining reporting. (USFA/EMS/FFIRS).
