The Fire and Emergency Incident Information System Technical Advisory Panel meeting was called to order at 1:10 p.m.

### **REPORT FROM DIVISION:** Given by Director Julius Halas

Director Halas welcomed the new members to the Panel and congratulated Bill Gulbrandsen on his retirement. Mr. Gulbrandsen will remain on the Panel representing the Association of Counties.

Director Halas announced the retirement of John Corbett from his position of Assistant Director with the State Fire Marshals' Office.

In a letter from CFO Jeff Atwater, he stated that with this being Public Service Recognition week, he wanted to recognize the outstanding team of public servants at the Department of Financial Services. Together with a solid team of committed individuals many key issues have been tackled in a relatively short time and he is excited to see what can be accomplished in the future.

NFIRS training at the National Fire Academy – "NFIRS Program Manager Course" (R491) is full.

As mentioned in the last meeting, Keith McCarthy (FFIRS) and Steve McCoy (EMS) together provided combined training. This training was extremely productive. A lot of

positive feedback was received. Steve and Keith hope to be able to provide more of this combined training in the future.

Year-to-date, a total of 92.5% of fire departments are participating in the FFIRS program.

There was an increase in reported incidents this year.

Departments are being encouraged not to wait until the end of the year to report as this affects the accuracy of the data.

Four years ago when this Panel was formed, reporting was at approximately 70%. We are currently at 92.5% reporting.

Daniel Stanley from the Division of Forestry asked if the data from their Division would be helpful.

Keith McCarthy stated that although the Division of Forestry has a "page" in the Annual Report listing their wildfire data, the data is not presently included in the database other than in a mutual aid format.

Keith and Daniel will meet separately to see if this can be changed.

Chief Baker stated that the purpose of the FDID number is to report data and suggested that if a department does not report data in a given year, they be issued a warning. If they fail to report the following year, their FDID number will be revoked. This would eliminate their opportunity to receive federal fire grant money. A penalty and warning associated with not reporting will be a great incentive.

Director Halas will research this option through Legal to determine if by Statute and Rule it would be permitted. An update will be provided at the next meeting.

## **REPORT FROM EMS:** Given by Steve McCoy

As mentioned by Keith McCarthy, Steve also reported that the joint training was extremely successful.

#### EMSTARS:

Currently Florida is one of the largest reporting states. The only state larger than Florida is North Carolina. North Carolina was the pilot state and have been entering data for five years which is a 3 or 4 year jump on Florida.

Every year, Florida runs approximately 3.1 - 3.2 million EMS calls. The Bureau just released its 2010 report which is called the "2010 EMS Provider Licensure and Call Volume Report"

This report is available on the Bureau's web site and is full of information concerning, organizational types, regions, transport vs. non-transport services etc.

Legislation:

HB 115 - Creation of Health and Human Services - no movement.

HB 589 – Non transport services – no movement.

SB 890 - The Bureau of Emergency Medical services regulates the certification of 911 dispatchers (911 Public Safety Telecommunicator). SB 890 – would allow law enforcement officers to temporarily act as 911 dispatchers – no movement.

SB 909 – House Bill –Emergency Medical Services Education – this bill would eliminate the 2 hour HIV/AIDS requirement for EMT and Paramedics for renewal.

This bill would also include making the Bureau's Strategic Plan from a two year to five year plan. The foundation of this bill is based on the change in the 1998 National Standard Curriculum for the new educational standard. This will update from 1998 to 2011.

HB 393 – Regulation of Professions – this bill would open up the PRN program for people with addictions. When they file for licensure they can then go into this program. This bill will open the program up to EMT and Paramedics however, this may cause some conflict between Chapter 456 and Chapter 401 because of a "definition" issue between "Health Care Provider" and "EMT/Paramedic" under Chapter 456. There has been no movement on this bill.

<u>Grants</u>: Closed. Almost three million dollars will be going back out to the services. Notice of awards will go out mid to the end of May.

<u>Inspections</u>: There are 76 inspections left to be completed. Year-to-date there have been approximately 43 announced inspections and 16 un-announced showing about a 91% compliance rate. The main issues being noted on EMS and engines are pediatric equipment.

<u>Education</u>: There are approximately 170 EMT/Paramedic programs being run throughout the state. There are over 500 continuing education programs available.

<u>911 Dispatchers/Public Safety Telecommunicators</u>: Approximately 3,500 are now certified. There are 30 approved training centers that currently provide the required training. The deadline for certification is October 1, 2012.

Due to cutbacks, the EMS Advisory Council meeting normally held in July will not take place.

As of July, the new Chairman for the EMS Advisory Council will be Battalion Chief Corey Victor from Indian River.

State EMS awards are in July. Hialeah Fire Department was voted EMS service provider of the year.


