## **REPORT FROM DIVISION:** Given by Director Julius Halas

- Accreditation update
- Florida Statute 633 "Clean-up" on-going.
- Legislative Affairs Regulatory Review remains high priority for the Department of Financial Services.

## **REPORT FROM FFIRS:** Given by Jon Pasqualone (Chair)

- 2011 533 fire departments participated in FFIRS (92.53%) 2.5 million incidents.
- New version of DET 5.9.2 is available for download.
- Training continues throughout the State.

## **REPORT FROM EMS:** *Given by Steve McCoy, EMS*

- Rules & Legislation HB 1263 passed, Bureau is now know as the Bureau of Emergency Medical Oversight and includes;
  - EMS
  - Trauma
  - Injury Prevention
  - Brain & Spinal Cord Injury Program
- Licensure
  - 271 services
  - 4,000 permitted vehicles
  - 78 inspections (50% announced)
- Grants
- 139 applications
- 52 awarded (2.4 million)
- EMT/Paramedics 65,000
- Schools 181
- Licensed Dispatch over 5,000
- EMS Children's Program continues to provide free training for EMS providers. If interested in receiving training, contact the Bureau.
- Investigations
  - 128 Complaints (EMT/Paramedics) last quarter
    - 28 Complaints on agencies
      - Actions
        - 7 relinquished licenses
        - 58 fined

- 61 cases closed
- EMSTARS
  - 138 out of 271 providers submitting data into the system, the remaining agencies submit quarterly.
  - Florida is still the largest reporting state in the country contributing to the national data set.
  - The system has been upgraded (only upgrade in last 6 years) this update caused the State to have to make changes to its system.
  - Work is ongoing for the new system. EM Systems is the vendor that will be used for the new system. They will be conducting a business plan to interface the two systems (Fire/EMS). Florida will be a "test state" for this program. They were unable to commit to a time-line as of yet.
  - The new (3.0 product) will be tested over the next six months and the Bureau hopes to be entering data by the end of the 2<sup>nd</sup> quarter of 2013.

In the meantime the current program EMSTARS 1.4 will stay up and running.

- Working on linking hospital data with EMS records and will be able to provided outcome data back to the EMS agencies. This has been approved through DOH.
- Drug shortage (nationally) Bureau has developed a task force to work on this serious issue.

Director Halas noted that there has been some discussion on combining EMT/Firefighter into on program "Firemedic".

#### **NEW BUSINESS:**

**On a motion duly made**, a policy will be established for the Panel to rotate Chairman and Vice Chairman annually.

**Amended motion**: The Bureau staff will look into the most appropriate way to rotate Chairman and Vice Chairman of the Fire & Emergency Incident System Technical Advisory Panel.

Chairman Jon Pasqualone stated that in the event he wins the seat on the House of Representatives, he will then have to resign from both the Fire & Emergency Incident System Technical Advisory Panel as well as the Firefighters Employment, Standards & Training Council. AUDIENCE: None
