The Firefighters Employment, Standards and Training Council meeting was called to order.

On a motion duly made, the minutes from the Firefighters Employment, Standards and Training Council held on November 17, 2022, were approved.

REPORT FROM DIVISION: given by JoAnne Rice, Director

• Continuing work on the 8th Edition of the Florida Fire Prevention Code, shooting for completion by June 30, 2023

Director Rice reminded council members that the State Fire Marshal's (SFM) office relies on the FFIRS and FFESTC councils to bring information to the table. Members need to be a resource out in the State and bring information back. Challenged members to get fully engaged to provide SFM with tasks and challenges.

Director Rice thanked Kasie Crowe from the Florida Forest Service and presented him with a certificate of appreciation for his time on both the FFIRS and FFESTC Councils.

REPORT FROM THE BUREAU: given by Mark Harper Bureau Chief

As a follow up from the previous meeting, Chief Harper provided a handout referencing certifications and employment tracking. Data provided was over a three-year period.

Standards Section

- Firefighter Certification
 - \circ Firefighter II 46,087
 - \circ Firefighter I 3, 501
 - Firefighters employed 37, 665
 - Certifications issued 11, 082
 - CY 2022 2, 299 Firefighter II certified (last year 2, 416 were certified). We have experienced an increase during 2021 due to make up from 2020 COVID.
- Pro Board completed site visit Nov. 2022.

Training Section

- 2022 3, 548 students attended class
- This section receives between 900 1000 requests each month for new course approvals, class offerings, and instructor and training provider requests.
- Two course deliveries have been transitioned to virtual
 - Evaluating Performance Based Design
 - o SERP

• We have received (1/11/2023) a draft agreement from NFPA referencing the licensing agreement for Florida to be able to approve instructors to teach the Certified Fire Protection Specialist course. In review with SFM legal.

USAR

- FEMA position-specific training \$450K
- IMT training exercise \$76K
- Full-scale exercise (3 days) \$250K

Grants

- Volunteer Assistance Grant \$1 million
 - o Processed 21 applications which will obligate the \$1 million
- Decontamination Equipment Grant \$500K
 - Processed 36 applications. Primary eligible equipment PPE, extractors, and vehicle exhaust capture systems.
 - o Received almost \$2 million in requested equipment
 - Each grant requires a safety compliance inspection to be completed before approved

Deferred Building Maintenance – Federal funding - \$2,744,765

- Replace roof on Arson/Prevention building \$250,250
- Roof repairs on other buildings \$101,793
- Generator replacement \$275,000
- Paving Phase II \$275,000
- Building infrastructure settling \$1.5 million

- Fire Service Instructor (69A-37:0.59)
 - The Department conducted a workshop, and the record was held open to receive comments. Division making edits to text and will move to the Notice of Rule Development.
- Program of Study and Vocational Courses (69A-27.065)
 - Workshop was held, will advise when ready to move to Notice of Rule Development
- Definitions (69A-37.084)
 - o Adding "Title IV Program" to language
 - Workshop held, will advise when ready to move to Notice of Rule Development
