## **REPORT FROM FFIRS:** given by Willie Saulsberry, SFM

- YTD 2, 228,000 calls run
- State reporting to NFIRS has increased
- NERIS (revision of NFRIS) will be rolling out the end of this year
  - State managers from Oregon to Florida
    - Looking at LODD/FF injuries reporting
    - Looking at other short falls or other items that should be included such as lithium-ion battery incidents, etc.
- Annual Report
  - All reports should be in by January 15 and data will be analyzed
- Community Risk Reduction position should be filled soon with an additional "Training Specialist" position to assist as back up.
- Looking at getting help for smaller departments with technical deficiencies, by recruiting high school students with computer skills looking to complete required community service hours. Have already made contact with Gadsen and Leon County school boards.

# **REPORT FROM EMS:** given by Tom DiBernardo, Florida Department of Health

Introduced Sam Thurman, who will be assisting DOH with Biospatial training and assistance.

- Closing the year with over 4 million calls
- This year held the largest update of the national system, working on "getting the bugs out".
- Biospatial continues to work on the project of adding fire data into system.
  - Testing data
  - Biospatial is holding the data, and it is able to manipulate very well
  - Took Annual Report and made viewable in Biospatial. An agency can now login and see the Annual Report, but with their data.
  - $\circ$  By March, we expect to be able to analyze the fire data further.
