REPORT FROM DIVISION: Update deferred to Firefighters Employment, Standards and Training Council meeting.

REPORT FROM FFIRS: Melissa Dembicer, Division of State Fire Marshal (handout provided)

- New Database
 - o FFIRS received \$125,000 from the Legislature for a new FFIRS database. The Division will be working with IT, the Bureau of Fire Standards and Training and Forestry to connect to their systems (FCDICE, IQS and IROC)
 - o Funds must be used within the year
- Reporting Departments
 - o A large number of consolidations have taken place. Departments have been reminded that they need to contact FFIRS with any changes.
- Florida Fires/Annual Report
 - O Hoping to be ready to distribute the 2018 report by August
- 90.6% of existing fire departments reported for 2018. New grant recipients will now be included in reporting
- 2018
 - o 2 firefighter deaths
 - o 244 firefighter injuries
 - o 106 civilian death
- All Florida data has been submitted to USFA

REPORT FROM EMS: Tom DiBernardo, Bureau of EMS (guest)

- FDOH new software dashboards for EMS reporting
 - Department of Health now working with 30 rural counties (previously had minimal contact)
 - Immunization for members, although in Statute for quite some time, it is rarely used. There is more of a need now, especially during disasters. Although Hepatitis A is not required by OSHA, it is at an all-time high and should be considered.
 - o Over 95% of agencies reporting
 - Cardiac Arrest Registry is another database collecting data along with the hospitals. This registry is free for any agency interested

- Biospatial
 - o Department of Health already has this program at no cost
 - O This program is a "viewer of your data" and is attached to;
 - Crash records
 - Opioid records
 - Overdose record databases
 - Provides real time live data
 - o FFIRS may be interested in this to view FFIRS data
 - o Can compare data with other states
 - Can look at police traffic records and EMS calls where police and/or fire were present
 - o Can import police records into your records
 - o Good data management
 - o Available free to departments with permanent EMS agencies
